সীমান্তবর্তী এলাকা শুকদেবপুরে কাঁটাতারের বেড়া না-থাকায় বাংলাদেশি দুষ্কৃতিদের তাণ্ডব

নিরাপত্তায় জেলা প্রশাসন ও বিএসএফের বৈঠক

নিজস্ব প্রতিবেদন, মালদা: বৃহস্পতিবার বাংলাদেশ জুড়ে ভোট তার আগেই মালদার ভারত-বাংলাদেশ সীমান্তের কাঁটাতার বিহীন শুকদেবপুর এলাকার গ্রামবাসীদের মধ্যে আতঙ্ক রয়েছে। শুকদেবপুর এলাকার বাসিন্দা জয় মণ্ডল, বিকাশ মন্ডলের ভক্তব্য, 'গত এক বছর ধরেই বাংলাদেশের ইউনুস সরকারের আমলে ফসল লুটতরাজ চলছে। এই এলাকার প্রায় এক কিলোমিটার সীমান্তে কাঁটাতার নেই। আমরা চাই অবিলম্বেই কাঁটাতারের বেড়া দেওয়ার কাজ সম্পূর্ণ করা হোক। ইতিমধ্যে গ্রামবাসীরা প্রশাসনকে নিজেদের সীমান্তে থাকা জমি দেওয়ারও কথা জানিয়েছেন।'



এদিকে বৃহস্পতিবার বাংলাদেশের নির্বাচন সংক্রান্ত বিষয় নিয়েই জেলা প্রশাসন ও স্থানীয় বিএসএফ কর্তৃপক্ষ নিরাপত্তার বিষয়ে একটি বৈঠক করেছেন। উল্লেখ্য, গত বছর জানুয়ারি মাস থেকেই কাঁটা তারে সীমানা দেওয়াকে ঘিরে শুরু হয় মালদার কালিয়াচক ও ব্লকের অন্তর্গত বৈষ্ণবনগর থানার শুকদেবপুর এলাকার

ভারত-বাংলাদেশ সীমান্তে অশান্তি। কিন্তু আজ পর্যন্ত জমি জটের কারণে ওই সীমান্ত কাঁটাতারের বেড়া দেওয়ার কাজ সম্পূর্ণ করতে পারেনি বিএসএফ। আর তারই সুযোগে বাংলাদেশি দুষ্কৃতিদের ফসল চুরির তাণ্ডব এখনও অব্যাহত রয়েছে বলে অভিযোগ। রাতের অন্ধকারে কাঁটাতার নাহলেই বাংলাদেশের দুষ্কৃতির ফসল লুটের কাণ্ড ঘটতে পারে। এই পরিস্থিতির মধ্যে বৃহস্পতিবার বাংলাদেশের ভোট রয়েছে। সেদিকেও লক্ষ্য রেখে উন্মুক্ত সীমান্ত এলাকার বাসিন্দারা আতঙ্কিত মনেই রয়েছে। বাংলাদেশি দুষ্কৃতিদের ফসল চুরির তাণ্ডব সংশ্লিষ্ট এলাকার কর্তব্যরত বিএসএফ জওয়ানদের জানানোর পর তারা ঘটনাস্থলে

সৌহার্দেই তখন ওপারে দুষ্কৃতির পালিয়ে যাচ্ছে। কিন্তু এভাবে কতদিন চলতে হবে তা নিয়েও প্রশ্ন তুলে দিয়েছেন শুকদেবপুর এলাকার সীমান্তবর্তী গ্রামের শতাধিক বাসিন্দারা। বিএসএফ ও প্রশাসন সূত্রে জানা গিয়েছে, শুকদেবপুর এলাকার ভারত-বাংলাদেশ সীমান্তের প্রায় এক কিলোমিটার এলাকা জুড়ে কাঁটাতারের বেড়া নেই। মূলত সেখান দিয়েই ওপারে দুষ্কৃতির কখনও গরু পাচার করতে গ্রামে ঢুকছে। আবার কখনও বিধার পর বিধা জমির ফসল ও সবজি কেটে পালিয়ে যাচ্ছে। এর মধ্যে আবার বাংলাদেশের নির্বাচন। কিছুটা হলেও আতঙ্ক রয়েছে।

ইতিমধ্যে বিএসএফের পক্ষ থেকেই খোলা সীমান্ত এলাকায় রাতের সার্চলাইট বসানোর কথা জানানো হয়েছে। কিন্তু তারপরেও সবজি ও ফসল চুরির অভিযোগ উঠেছে। বাংলাদেশের নির্বাচনের পরিস্থিতির দিকে লক্ষ্য রেখেই বিএসএফের টহল বেড়েছে। সীমান্তবর্তী গ্রামগুলিতেও বলে জানানো হয়েছে। পুলিশ সুপার অভিভূত বন্দোপাধ্যায় জানিয়েছেন, 'মালদার বিভিন্ন সীমান্ত এলাকায় পুলিশ টহলদারি বাড়ানো হয়েছে। ভারত বাংলাদেশ সীমান্তবর্তী বিভিন্ন এলাকায় নানান গতিবিধি ওপারে বিশেষ নজরদারি চালানো হচ্ছে।'
